

## **Cookie handling description of Resolution Fund of Hungary, (RF)**

Visitors of RF's webpage can get access to information regarding the structure, tasks, and operation of RF, as well as the operations related news without providing any personal information. The RF webpage does not record any kind of personal information of the visitors.

However, like many other webpages the RF's page also uses cookies. These cookies let us to operate our webpage on a higher level to increase our visitors' satisfaction, as well as collection of anonymous visitor statistics to improve our service level regarding the usefulness of our page.

During the first page access the visitor must accept the cookie consent, a kind of a declaration regarding what sort of cookies the visitor allows to run besides the cookies necessary to the proper operation of the webpage, e.g. (preferences, statistics, and marketing cookies). This cookie panel appears at the bottom of the opening main page and the visitors can make their consent using that panel. After the consent has been made the cookie panel does not reappear again during the later visits of the webpage. Changing the cookie setting can be done with a new declaration. In order to do that, (to force the cookie panel to reappear again) the visitor has to delete the cookies regarding this webpage from his/her computer or mobile device, (see below the necessary setting of the different web browsers). After deleting the cookies, the cookie panel reappears again, and the modified consent can be made.

The stored cookies can be deleted from the browser of the device anytime, furthermore the browser can block the cookies from running (see below how to setup the cookie settings of different browsers). However, by blocking the cookies the visitor accepts that the operation of the page would not be necessarily perfect.

### Necessary cookies

Without these cookies the webpage does not operate properly. These cookies run always. Usually, they start to operate in according to the visitors browsing movements, e.g., data management, login processes or filling up webforms.

Name of the cookie	Description	Expiry*
Cookieconsent	Stores the cookie consent of the visitor regarding the visited webpage.	1 year
PHPSESSID	Required for the proper operation of the webpage.	At the end of the browsing session.
pll_language	This cookie tries to set up the language of the page after the default language of the visitor's browser having identified – if that is possible.	1 year

**Preference cookies:** the page does not use this kind of cookies.

### Statistics cookies

RF's webpage uses Google Analytics, (GA) to collect webpage visitor statistics to improve the visitors' browsing satisfaction and identify the future development needs. GA stores the information regarding the visited pages and subpages, as well as the duration of the visit and the origin country of the visitors.
